Project Description: The Department is proposing to modify the SPDES permit for the Charles Poletti Power Project. Poletti burns either natural gas or #6 fuel oil to produce a maximum of 885 MW using a once-through cooling system. The once-through cooling system withdraws water from the East River with a nominal cooling water flow of 622 million gallons per day (MGD). The cooling water intake consists of two circulating water pumps with variable speed motors, two screenwash pumps, two service water pumps with variable speed motors, four traveling screens, and four trash racks. The facility began operations in 1977, but according to a stipulation agreement will cease operation as early as 1 February 2008, but no later than 1 February

2010. This SPDES permit authorizes the discharge of non-contact cooling water, treated wastewater, boiler blowdown, and storm water to the East River. The modifications to the SPDES permit being contemplated by the Department include an update of monitoring information, and require NYPA to submit data and analyses related to the once-through cooling system. The information will be utilized by the Department to determine best technology available for minimizing adverse impacts to the aquatic resources of the East River. NYPA will also be required to review possible technologies and operational measures to minimize aquatic impacts. The information is being requested pursuant to 6 NYCRR Part 704.5 and 40 CFR 125 - Subpart J. The Charles Poletti Power Project is located in Astoria, Queens. either direction on a No. 7 train, are not only an eyesore but a visual incentive to apply graffiti all along the train line, as indeed it has been applied. Yule, sensing the suggestion that graffiti vandals are coming from afar to loose the contents of their spray cans on Sunnyside and environs, reminded the audience that the arrested youth he talked about is a local resident. Condes brought up an old lament: that he can't persuade anyone of the efficacy of the Chicago plan. In that city, cans of spray paint cannot be sold to minors, he said, and as a result, Chicago's graffiti problem is not nearly as bad as New York's. Gaskin didn't take him up on it either, but reminded the audience that if you see a graffiti crime in progress, phone 911; but if you discover graffiti after the perpetrator has struck, phone 311. Do not in any circumstances try to interfere with anyone defacing any surface with graffiti, since that would be dangerous, he said.

The good word for the missing Capt. Whelan was put in by Community Council President Diane Ballek, who said he should be a deputy inspector, as are the commanders in other precincts such as the 114th and 115th. She said

that Whelan is the sixth commander she has worked with in 10 years with the council. The other five were all advanced to deputy inspector, but only after leaving the precinct for further assignments, Ballek said. She added that it's time the 108th Precinct had a deputy inspector in place.

Some 19 so-called Sugar Plum Rose awards were on display at the meeting prior to their being distributed to local businesses and institutions in recognition of meritorious service and contributions during the past year. All are designed by the community council's Pat Dorfman and consist of four large framed awards and 14 smaller ones. The four big-award winners are *Police Officers' Quarterly*; Skyline Credit Ridging; Waterfront Crabhouse (a representative of which was the only recipient present at the meeting to receive it); and White Castle.
