25-39 44th St. and charged with assault with intent to cause physical injury after a victim stated that the perpetrator punched him repeatedly in the face.

- When a 47-year-old Asian woman was arrested at 23rd Avenue and 29th Street for an open complaint for aggravated harassment, she was found to have a stun gun in her purse. She was charged with aggravated harassment and criminal possession of a weapon.
