Edison for not offering an apology as yet. Gioia questioned Con Ed's decision to relieve firefighters prior to the explosion. The Queens lawmaker is also waiting for someone to tell him why area residents were not evacuated sooner. "This is unacceptable," said Gioia, who also said Con Ed is "incapable of investigating themselves." Gioia is calling for the state attorney general and the U.S. Attorney's Office to investigate the blast. Gioia questioned Con Ed's failure to prevent the tragedy. "While it is too soon to draw firm conclusions, I am certain of one thing: Con Ed cannot be trusted to investigate itself. Our neighborhood has been scarred by Con
